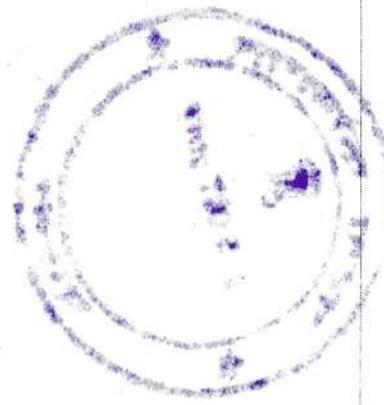

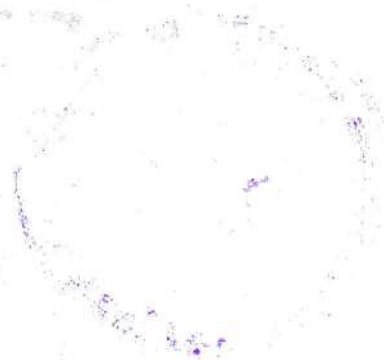
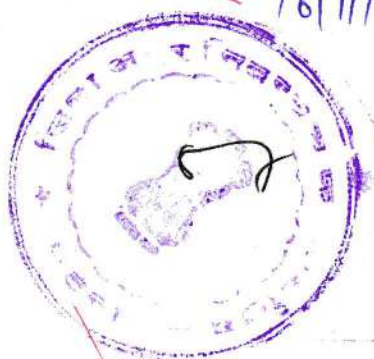

And whereas if the Trustees desire to co-opt another eminent personalities as trustees for betterment of trust, they can co-opt.

And whereas if any vacancy made in Board of trustees these vacancy can be fulfilled by Co-option. Whereas the Settler is desirous of establishing a trust for public charitable objects.

And whereas the Trustees have, at the request of the settler, agreed to act as the first trustees of these presents as testified their being parties to and executing these presents.

And whereas it is necessary to declare the aims and objects of the public charitable public Trust, being constituted under these presents.

Now this indenture witnesseth as follows:-

1. That , in order to effectuate his aforesaid desire , the settler has set apart and handed over to the trustees , a sum of Rs. 51,000 Fifty one Thousand (hereinafter called the Trust Fund which expression shall include cash and any other property of investments of any kind whatsoever into which the same or any part thereof might be converted invested or varied from time to

time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

That the name of the trust shall **HODA WELFARE FOUNDATION** and office will be situated **32, Patliputra Colony, P.O + P.S- Patliputra Colony, Patna-800013, Bihar. (INDIA)** And / or at such other place or places as the trustees may decide from time to time.

2. That the objects for which this trust is established are :

1. To create a sense of brotherhood, co-operation, mutual harmony, love and affection amongst the member of the Trust and also amongst the general public.

2. To start, establish, run take over or manage and maintain the school, with the object to provide sound nursery, pre- primary, Middle, secondary, senior secondary schools and higher education to children/students by seeking recognition and affiliation from the education departments etc.

3. To establish, run maintain and grant aid in cash or kinds to advance technical education, colleges including engineering & Diploma Colleges, Medical college, Management Education Institute, Computer Science & Engineering Institutes & specialized studies & research institutes to provide standard and high class education for B.Ed, B.E./B. Tech/B. Arc/MBA, B.B.A, Bsc IT, B.C.A, Nursing, Nutrition, Dietetics, yoga fitness, Non formal education, Hospitality Management, Computer Literacy & Training Paramedical, courses and other related courses to the students according to rules and regulations of UGC, All India council for technical education, National council for vocational Training, National council for Teacher's Education, Nursing council of India & state government.

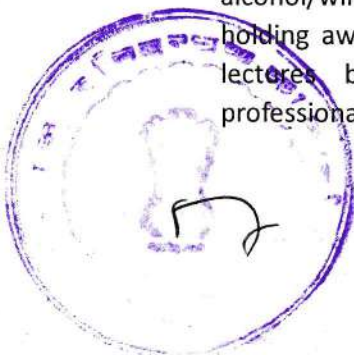
4. To organize camps, training, seminar, press conference, exhibition, Nukadd Natak and other programme on disaster management and other related problems.

9. To help the street children by providing them shelter, food and education.

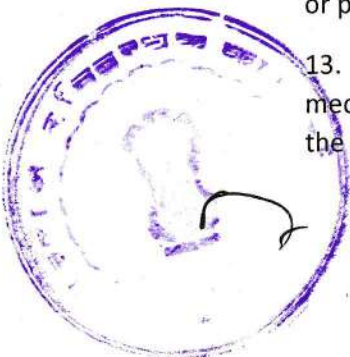

13. To provide food, cloths, shelter (temporary/permanent), medicines and other required facilities to the people who have faced the Natural Calamity and/or the disaster.

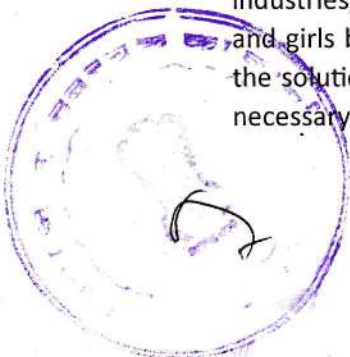


14. To make best efforts for protection, promotion and for the advancement of women, children, old aged, handicapped, orphans, widows, destitute and mentally retarded persons.

23. To arrange and organize exhibitions, training and research programs on the subjects/matters relating to the villagers and people belongs to the rural areas and tribal areas of the India and also start different integrated village development' programs in all over India
24. To approach the farmers (and the people connected with agriculture) and provide them the latest technology and the research information in the fields of agriculture for the betterment of farmers/agriculturists.

45. To run management institutes/ professional courses in the field of finance including international finance, business management, commerce, computer application and allied subjects/activities.

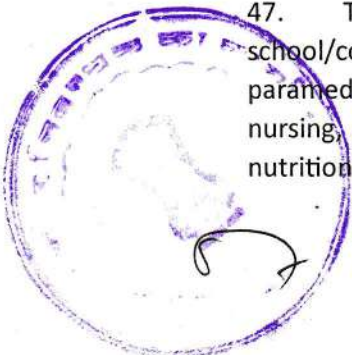

54. To undertake , carryout , promote, sponsor , discharge, full fill , participate , collaborate, manage or organise the programmes with peoples co-operation , national and international Government and Non- Government agencies and to carry-out all necessary acts for the achievement of the objectives .

55. To accept loan, Grant-in Aid, donation (either in cash or kind), subsidy or other assistance lawfully, either from national and / or International agencies for the attainment of the objective of the Trust.

56. To undertake , organise , investigate , participate , sponsor , the human right programmes including awakening of human right , preservation of fundamental rights , protection & safeguards to the victims of human right violations, for the freedom, dignity and peace of the people . Also undertake study, research , publications , treaties with national and international institutions and award programmes, for the effective implementation of Human Rights.

66. To promote the alternative sources of energy like bio-gas, solar through the environmental programme.

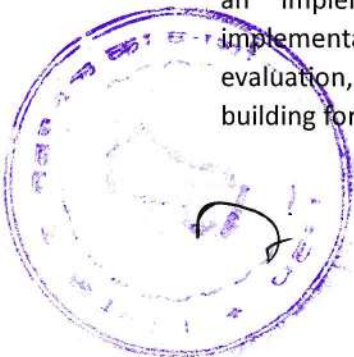
67. To promote mahila mandals, self help groups, youth groups, women empowerment for the development of women, youth and children.

71. To offer management consultancy and implementation & support services to various state, central government organisation.

72. To work for the promotion of folk culture, music, and other arts of different areas and protect them from vanishing by organising functions and encouraging artists.

3 All the activities shall be Non-Profitable and shall be done on No Profit - No Loss basis.

4 All the incomes, earnings, movable / immovable properties of the Trust shall be solely utilized and applied towards the promotion of its Aims and objects only as set forth in the deed of the Trust and no profit there of shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or the past member of the Trust or to any person claiming through any one more of the present or the past members. No members of the Trust shall have any personal claim on any movable or immovable properties of the Trust or make any profits, whatsoever, by virtue of his membership.

5. That the Trust Fund may be augmented by the income from the initial fund also by donations and other contribution from time to time.

6. That the Trust Fund shall not be applied for any purpose other than those specified in Para 3 herein above unless the other objects added to the trust objectives.

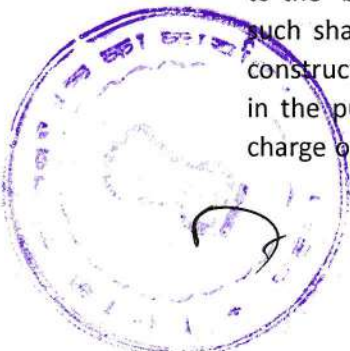
7. That the Trustees shall always maintain proper accounts of the Trust, which shall be kept at the office of the Trust.

8. Subject to the provisions of Income Tax Act. 1961 as amended from time to time, the Trustees will keep the Trust Fund of such portion thereof, as they may, in their absolute discretion, think fit and proper, without being answerable or accountable to the beneficiaries or any other party for any loss invested in such shares, stock, securities and debentures of acquisition or construction of any immovable property including building and /or in the purchase and acquisition or mortgage by way of fresh charge on any immovable property in India, of free-hold or lease -

hold tenure, and may deposit the amounts with any scheduled Bank, Company or Private firm any Individual on such terms and conditions as they think fit, in the matter of investment of Trust funds, the provisions of section 20 of the Indian Trust Act shall apply, in the event of Trustees purchasing any immovable property or properties or advancing moneys or mortgage, they shall be entitled to accept such title or evidence of title as they shall think fit in their absolute and uncontrolled discretion. The Trustees shall have power, if any deed it in their absolute discretion to sell the Trust Fund or any part thereof and any such immovable property purchased by them under the power aforesaid and any other shares, securities, etc. and stand possessed of the money to arise from such sale upon after paying there out the expenses pertaining to such sale upon the Trusts and with the subject to powers and provision including and all the posers contained by and under these presents declared and contained concerning the Trust Fund which or the proceeds thereof, shall have laid out in purchase of property or properties as have laid out in purchase of property or properties as aforesaid or such of them as shall be then subsisting and capable of taking effect.

9. That for the furtherance of the objects of the Trust, the Trustees shall have the following powers:

(i) To accept any donation, contribution, Loan Grant or subscription in cash or in kind, from any person (S) or association of person (S) or body corporate or Trust with or without conditions.

(ii) To apply the whole or any part of the income of the Trust, or the Trust fund or accumulations there to, any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.

(iii) To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.

(iv) To open account in the name of the Trust, with a bank or banks to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees. But the signature of the settler -cum -trustee is compulsory

(v) To adjust, settle, compromise, compound refers to arbitration, all actions. Suits claims, demands and proceedings regarding the Trust fund.

(vi) To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator or settler -cum - trustees or otherwise) for the

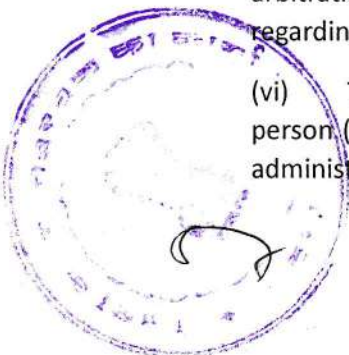

purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.

(vii) To make very alter or modify schemes , rules and regulations for carrying out the objects of the Trust and for the management of the affairs there of and /or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust .

(viii) To start , abolish , discontinuations and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them .

(ix) To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or the part there of for any of the objects of the Trust .

(x) To join , co-operate or amalgamate this Trust with other or others having kindred or allied objects, upon such terms and conditions as the Trustees may in their discretion think fit ,particularly having regard to and in conformity with the objects and nature of this Trust.

(xi) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise ,to different charitable institutions , societies, organisations or Trust in India which may have been established or which may hereinafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, organisation or Trustees to start maintain, or carry out such charitable objects.

(xii) To settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.

(xiii) To borrow money either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

(xiv) To apply to the Government, public bodies, urban, local municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance including lease and substance of property with a view to promote the objects of the Trust and to discuss and negotiate with the Government

Departments, public and other bodies corporations, companies or persons, scheme and ~~other work and matters~~ within the objects of the Trust and to put to any proper condition upon which such grants and other payments including taking land on lease may be made.

(xv) To take over or amalgamate with any other Charitable Public Trust, Trust, association, or institution with similar objects.

(xvi) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.

(xvii) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.

(xviii) To take land/property on lease and then after sublease the land/property to the farmers and other organizations like co-operative/society/urban public bodies/gram panchayat or any being thereof in rural area/local municipal/district and other bodies corporation/company for farming/agriculture /plantation purposes.

10. The Trustees shall be accountable only for such money, and funds, which will actually come into their hands.

11. The Trustees will not be entitled to receive any remuneration, but the Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

12. The Settler-cum- Trustee for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and reappointment as the trustees for the time being consider proper.

13. A person shall cease to be a Trustee either:

- If he is requested to resign by 2/3rd or as near thereto as possible of the remaining trustees.

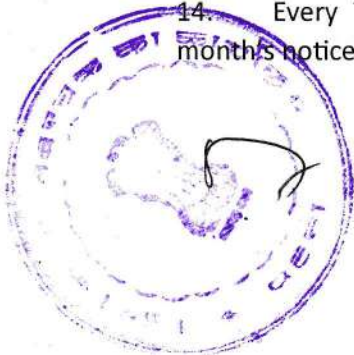
